1.	<p>Question</p> <p>Does Chinese bidders (legal entity registered in China) apply to the Centralized Supplier Database (CSD)?</p> <p>Response</p> <p>No, Only South African companies must register</p>
2	<p>Question</p> <p>Does Chinese bidders (legal entity registered in China) apply to the B-BBEE status level certificate?</p> <p>Response</p> <p>No, B-BBEE does not apply for this Tender.</p>
3	<p>Question</p> <p>What documents should the Chinese bidders (legal entity registered in China) submit for the tax compliance?</p> <p>Response</p> <p>Besides the business license issued by the relevant Chinese commercial authorities, the bidders should obtain the certificates of tax clearance from online tax platform operated by China tax authority. (除提交公司营业执照以外，投标人还需从中国电子税务平台内申请无欠税证明和完税证明)。</p>

4	<p>Question</p> <p>Share certificates need to be shared as part of the process. However, we are a huge company and have over 1000 share holders and it would be impossible to get all the share certificates stamped. Can I share a list of the share certificates instead and get them signed internally</p> <p>Response</p> <p>Yes, you may share a list.</p>
5	<p>Question</p> <p>Shall we have the compulsory brief session?</p> <p>Response</p> <p>The tender does not have a compulsory brief session or briefing. We rectifying the first page of the Part B, No Compulsory brief.</p> <p>Question</p> <p>Do we need send the registration to Mr. Simon Wang for the bidding?</p> <p>Response</p> <p>No. all the submissions must be directly to the e-procurement portal before the closing date. The link is https://e-procurement.southafrica.net</p> <p>Question</p> <p>Must it be a full plan for SAT including campaign themes and ideas for the submission before closing date 30 November 2023?</p> <p>Response</p> <p>Yes, SA Tourism will not request additional information from the supplier after closing or during the evaluation.</p> <p>Question</p> <p>How many agencies have been invited to pitch for the tender</p> <p>Response</p> <p>As per the Part C document, bidder(s) who score the set threshold will be invited for presentation.</p>
